**The main aims of the Trust** are to promote education about the culture and way of life of Tibetan people and the subject of Tibetan Buddhism through meditation, religious observance and the provision of financial support to Buddhist monks, nuns and others in need including children, elders and university students.

Our current sponsorship schemes:

- **School children:** £15 per month (£180 pa)
- **Elderly refugees:** £10 per month (£120 pa)
- **University students:** £500 pa
- **Monks / Nuns:** £15 per month (£180 pa)
